District Councillor Toni Bradnum advised that the Christmas Fantasia at Camping World will be closing on 14th January 2017. There have been a number parking issues at the weekends and Hilliers are not happy with the parking arrangements. The Police have been called, but the parking is not a priority and the matter is a licencing issue.

There is no further update on the planning application for the Dun Horse. An application for the gates in Sedgwick Park will be submitted to HDC, legal matters are still ongoing.

An application has been submitted by Britaniacrest for a large plant, at the brickworks off the A264, close to the Great Daux Roundabout. The application includes an incinerator and chimney, the height of big ben.

The Clerk was asked to include the application on the next Planning Committee agenda.

Neighbourhood Planning, Barriers to Delivery b) The members supported the content of the letter Claire Vickers had written to the Minister of State for Housing & Planning, however, there were concerns about the statement that developers should be involved. Councillor O Hydes volunteered to draft a letter to Cllr Claire Vickers highlighting the Parish Councils concerns about developer involvement.

Undetermined Planning Applications c) There are five undetermined planning applications in the parish. A developer can appeal to have an application determined by the Planning Inspectorate when the local planning authority has failed to determine an application by the due date. This happened in the case of planning application DC/13/2393 (four detached houses south of Woodlands Chase, Sedgwick Lane) where outline planning permission was

granted by the Planning Inspectorate.

2001/17 COMMUNITY WARDENS

Trevor Leggo, Chief Executive of SSAL will be making a presentation on Community Wardens at the Full Parish Council meeting on 1st February 2017, Councillors from Lower Beeding and Cowfold Parish Councils have also been invited to attend.

Five of the thirty-three parishes in the District have Community Wardens, including Ashington, Pulborough, Steyning and Bramber. The cost of a Community Warden is approximately £22,000.00 per annum, there is possible grant funding available from Sussex Police for the first two years. Neighbourhood Watch is very prevalent in the Parish.
