FC002-21/22 APPOINT THE CHAIRMAN OF THE FINANCE COMMITTEE

It was **RESOLVED** that Cllr T Nelson be elected Chairman of the Finance Committee for the 2021/22 municipal year. **PROPOSED** by Cllr N Bryant and **SECONDED** by Cllr C Kenny (unanimous decision).

FC003-21/22 APPOINT THE VICE CHAIRMAN OF THE FINANCE COMMITTEE

It was **RESOLVED** that Cllr C Kenny be elected Vice Chairman of the Finance Committee for the 2021/22 municipal year. **PROPOSED** by Cllr N Bryant and **SECONDED** by Cllr O Hydes (unanimous decision).

It was **RESOLVED** to **NOTE** that no member of the public present at the meeting wished to speak in the public forum.

FC009-21/22 REVIEW OF CURRENT FINANCIAL YEAR

It was **RESOLVED** to **NOTE** that the financial position of the Parish Council is slightly more fluid than over the last few years. The <u>annual expenditure</u> is on track with 46% of the budget being spent in the first six months of the financial year. Barring any unforeseen costs at the end of the financial year expenditure should be under budget and the Budget Contingency will not be used.

The account for 2020/21 have been approved by the external auditor with no recommendations for improvement.

FC010-21/22 REVIEW OF S106 AND CIL FUNDS

It was **RESOLVED** to **NOTE** that the Parish Council have a balance of £24,034.10 from CIL funds received from HDC in 2020. No further CIL funds are expected in the 2021/22 financial year (latest <u>\$106</u> and <u>CIL</u> reports).

The Chairman of the Finance Committee explained that he was reluctant to recommend that the Parish Council use their General Reserves or take a loan to finance the project. He added that the Parish Council need to `spread themselves throughout the community, not just the children's play area.'

It was **RESOLVED** to make the following **RECOMMENDATION** to Full Parish Council: To increase the budget for updating the children's play area to £31,000. This could be slightly increased towards the end of the financial year. Also, to contact local companies and try to secure additional funding through sponsorship.
